Subject (title): Rescinding Chapter 4-3 (Child Protection Team) for Second Reading and Final Approval

WHEREAS: Under Article VI, Section 2 of the Constitution of the Confederated Tribes of Coos, Lower Umpqua and Siuslaw Indians of Oregon ("Constitution"), the Tribal Council is authorized to exercise all legislative and executive authority of the Confederated Tribes of Coos, Lower Umpqua and Siuslaw Indians ("Tribe" or "CTCLUSI"); and

WHEREAS: Under Article VI, Section 4 of the Constitution, all final decisions of Tribal Council shall be embodied in ordinances or resolutions; and

WHEREAS: The Tribal Council enacted Chapter 4-3 (Child Protection Team) by Resolution No. 01-058, Ordinance No. 027, in a Tribal Council meeting on June 26, 2001; and

WHEREAS: The Child Protection Team has been defunct, would require significant training for members to be effective, and could result in significant harm to children and liability to the Tribe if not properly implemented; and

WHEREAS: The Tribal Council acted on August 30, 2023 for a first reading and posted for 28 days for comment beginning on October 1, 2023; all comments received have been reviewed and considered; and

WHEREAS: The Tribal Council finds it is in the best interest of the Tribe and its members to rescind Chapter 4-3 (Child Protection Team).

THEREFORE, BE IT RESOLVED, on behalf of the Tribe, the Tribal Council hereby approves an amendment to rescind Chapter 4-3 (Child Protection Team) in its entirety, as set out in the attached Exhibit A hereto, and hereby approves such amendment for second reading and final approval.
